Patriot Mike Krebs

Patriot Mike Krebs was born and raised in Kenosha, Wisconsin. After graduating from high school, he enrolled at Marquette University where he majored in Electrical Engineering and was a midshipman in the NROTC unit at the university. Upon graduation, he was commissioned as an ensign and directed to report to flight school in Pensacola, Florida.

After 18 months of training, Mike was designated a Naval Aviator in June 1966 and assigned to Attack Squadron 44 at Cecil Field, Florida for additional training in the A4 Skyhawk, a single-seat jet light attack carrier aircraft. After completion of A4 training, he reported to VA34 located at Cecil Field, Florida, which deployed to Vietnam on the USS Intrepid (CVA/S 11) as part of Carrier Air Wing 10 for participation in Operation Rolling Thunder (May-November 1967), the campaign to bomb North Vietnam. On November 7, 1967 on a mission over North Vietnam, Mike's plane was hit by antiaircraft fire, damaging the left wing and setting the plane on fire. He was able to fly out to a rescue ship where he ejected near the Belknap (CG 26) that recovered him. Later that day, he was returned to the Intrepid.

Upon his squadron's return from Vietnam, it was reassigned to Air Wing 17 and deployed aboard the USS Forrestal (CVA 59) to the Mediterranean for 10 months. After returning to Cecil Field in May of 1969, Mike and Nancy had a full military wedding. Mike wrapped up his six years of active duty service as an A7 instructor pilot. During his service, he accumulated 267 carrier landings of which 50 were at night and 76 were combat missions. His personal awards include the Purple Heart, 7 Air Medals, Navy Commendation Medal with "V" for Valor and Navy Achievement Medal with "V" for Valor.

In January 1971, Mike left the Navy for a position with Electronic Data Systems (EDS), managing computer systems for clients and stayed with EDS for 29 years, making 6 cross-country moves. After retiring from EDS, he worked another 11 years at KB Home and Avery Dennison before retiring a second time. Mike and his wife Nancy have been married 54 years and have two grown children and two precious grandchildren. They relocated to Florida in 2016 for the warmer weather and have traveled extensively domestically and internationally since retirement.
